DOMFIL Rental contract

DOMFIL possesses an inventory of items that can be rented by members of DOMFIL. In exceptional cases, the Item can be also be rented by non-members. Renting an Item from DOMFIL means that you agree to DOMFIL's terms and conditions for renting the object. This contract states the terms and conditions regarding renting an Item from DOMFIL and the consequences of non-compliance.

Clarification of terms: Renter = Person to rent the Item. Item = DOMFIL:s Item that the Renter is about to rent.

§1 General rules

- The rentable Item is stored in a safe in Sektionsrummet, Cellbiologen, level 7.
- The Renter collects the Item by contacting the DOMFIL board to agree upon a meeting time when the appointed board member can meet up with the Renter and open the safe.
- The rental contract is signed upon collecting the Item.
- The rental cost and the deposition should be paid to DOMFIL's account before collecting the Item.
- The deposition will be transferred back to the Renter once the Item is back in DOMFIL's inventory on time and undamaged.
- The standard renting period for an Item is 7 days. The rented Item should be returned within that time period. During high demandable months, the renting period is reduced to 3 days.
- Returning an object is done through contacting the appointed board member of DOMFIL to agree upon a meeting time when the appointed board member can meet up with the Renter and open the safe.
- The rental period may be extended upon agreement with the DOMFIL board in advance, prior to the end of the original rental period. The decision to extend the rental period is up to the DOMFIL board and will only be done if it does not infringe on another booking.
- If the Item isn't returned within the decided rental period, this will result in the Renter losing their deposition.
- If the Item still isn't returned within 3 days after the end of the decided rental period, the Renter will be charged 200kr/day until the Item is returned.
- An Item that is returned damaged, broken or with missing pieces will result in the Renter losing the deposition. More details regarding this can be found under §2-4 for each individual Item.
- While in the Renter's possession, the Renter is responsible for the Item. This means that DOMFIL will hold the Renter responsible if the Item is damaged, broken or with missing pieces at for example an event that the Renter is hosting by an attendee.
- A general deposit of 500 SEK/Item applies for all rentals.
- Specific terms and conditions applies to individual items, see §2-4 below.

§2 Doctoral hats

- DOMFIL has 10 doctor's hats that are available for members to rent. Each hat costs 400 SEK to rent.
- A deposition of 500 SEK is paid upon renting the Item and returned by the end of the rental agreement.
- Hats should be returned whole and clean. If the hat has for example wine stains on it or smells of cigarette smoke, the Renter will have to pay for dry cleaning.
- Above general rules apply.

§3 Sound system

- DOMFIL has a sound system that is available for members to rent. The rental cost for the sound system is 700 SEK for members and 1000 SEK for non-members.
- A deposition of 500 SEK is paid upon renting the Item and returned by the end of the rental agreement.
- It is important that all pieces of the sound system is returned. This includes wires and manuals too. The deposition will be lost if a piece is missing.
- In the event that the cost of replacing said piece exceeds what the deposition covers, the Renter will be charged with the difference.
- The Renter should be careful with the sound system and take measures so that the Item is unlikely to be damaged during the rental period.
- If a part of the sound system or the peripherals are returned damaged, the Renter will be held liable and the deposition cost will be lost. If the system needs to be repaired or replaced as a result of the damages, the Renter will be charged the costs of doing so.
- Above general rules apply.

§4 Party tent

- DOMFIL has a big, outdoor party tent available to rent. The tent costs 400 SEK to rent.
- A deposition of 500 SEK is paid upon renting the Item and returned by the end of the rental agreement.
- All pieces of the Item needs to be returned in good condition.
- If the tent is missing pieces or is damaged (e.g. the fabric is ripped), this will result in the deposition being lost.
- If the Item is not repairable, the Renter will be charged of the cost to replace the whole tent.
- Above general rules apply.
