In the meeting with Anna Strömberg, we discussed the procedure to ask for compensation from PhD student representatives. Regarding the prolongation, the student unions send the following email that they got from 2020:

"Den administrative chefen på institutionen får underlag från doktorand och HR-partners om under vilken tid och vilka uppdrag som doktoranden har haft. Administrative chefen sammanställer detta till ett underlag för institutionen där avstämning sker med tex koordinatorerna för forskarutbildning som finns på institutionerna.

- Underlaget lämnas till HR-direktören som sedan fattar beslut om hur många dagar som skall adderas till doktorandens studietid. Beslutet meddelas till institutionen och doktoranden.
- Denna avstämning sker med årlig frekvens men i praktiken brukar det summeras till 2 år i taget så att under en doktorandperiod fattas maximalt två beslut om prolongering för en doktorand".
